#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office for Victims of Crime</u> (OVC) seeks applications for funding for the Building State Technology Capacity and Jabara-Heyer No HATE Act State-Run Hate Crime Reporting Hotlines program. This program furthers the DOJ's mission by (under Purpose Area 1) enhancing states' use of technology for the purpose of providing improved service to crime victims, and (under Purpose Area 2) supporting Jabara-Heyer No HATE Act state-run hate crime reporting hotlines.

## State governments

For purposes of this solicitation, "state" means any state of the United States, the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands.

For Purpose Area 1, applicants must be Victims of Crime Act (VOCA) Formula Assistance and Compensation Program State Administering Agencies (SAAs). For Purpose Area 2, applicants must be state agencies (not limited to VOCA SAAs).

To advance Executive Order 13929 Safe Policing for Safe Communities, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process, to be eligible for FY 2022 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's use-of-force policies adhere to all applicable federal, state, and local laws and (2) the agency's use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. # **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community. This solicitation has two purpose areas for application:

Purpose Area 1: OVC is seeking applications from Victims of Crime Act (VOCA) Formula Assistance and Compensation Program State Administering Agencies (SAA) to implement statewide technology programs to enhance victims' access to services, foster innovation and efficiency in providing services, improve the quality of services, and improve the accessibility and responsiveness of victim service organizations.

Purpose Area 2: OVC is seeking applications under the Grants for State-Run Hate Crime Hotlines provision of 2021 (34 U.S.C. 30507(e)) to establish state-run hate crime hotlines to assist victims who might otherwise be reluctant to report these crimes.

Agencies can apply for both purpose areas, but they must submit a separate application for each

#### **Specific Information**

#### Purpose Area 1:

The Building State Technology Capacity and State-Run HATE Crime Reporting Hotlines program serves victims by allowing SAAs to leverage technology to improve access to or delivery of services to victims of crime. By investing in technological innovation, SAAs may increase organizational capacity, enhance data collection and analysis, and expand access to support victims, including those in underserved and historically marginalized communities.

- Develop and/or implement technology to enhance outreach to victims of crime.
- Develop and/or implement technology to assist the State Victim Assistance and Compensation Programs.
- Use technology to effectively communicate about, report on, and monitor VOCA program activities.
- Enhance the collection of performance measures related to elder abuse and other types of victimization.
- Enhance the social media presence of SAAs and other victim service providers.
- Enhance victim compensation technology to increase efficiency and reduce claim-processing time.
- Develop and/or implement technology to improve state and subgrantee reporting.

  Develop or enhance the statewide grants management systems used for the VOCA formula programs.
- Enhance technology systems to improve their security, confidentiality, and efficiency regarding the victims' data they store.

# Purpose Area 2:

The Building State Technology Capacity and Jabara-Heyer No HATE Act State-Run Hate Crime Reporting Hotlines program authorizes grants to states to create state-run hate crime reporting hotlines. The state applicant is required by law and under this solicitation to ensure the following:

- The hotline will direct victims of hate crime to—
  - · law enforcement if appropriate, and
  - local support services.
- Any personally identifiable information that an individual provides to an agency of the state through the hotlines is not directly or indirectly disclosed without the consent of the individual, to-
  - · any other agency of the state,
  - any other state,
  - · the federal government, or
  - any other person or entity.
- The staff members who operate the hotline are trained to be knowledgeable about—
  - · applicable federal, state, and local hate crime laws,

- · local law enforcement resources, and
- applicable local support services.
- The hotline is accessible to-
  - · individuals with limited English proficiency, and
  - · individuals with disabilities.

#### Goals, Objectives, Deliverables, and Timeline

#### Purpose Area 1:

The goal of Purpose Area 1 is to implement statewide technology programs to enhance victims' access to services, increase equity in services and access, foster innovation and efficiency in the provision of services, improve the quality of services, and improve the accessibility and responsiveness of victim service organizations.

#### Purpose Area 2:

Purpose Area 2 seeks to provide grants for state agencies to establish and run hate crime reporting hotlines, to facilitate significantly increased reporting of hate crimes data, and to ensure that victims and witnesses are connected to law enforcement and local support services as needed. The goal is to ensure that hate crimes do not go unreported and that victims have access to needed services.

- 1. Conduct strategic planning to identify gaps and implement the strategic plan to enhance statewide technological capacities for both purpose areas.

- 4. Collect data and participate in evaluation activities to determine if the program is meeting its stated goals and objectives.

Successful applicants will achieve this goal through the following objectives:

- 1. Conduct strategic planning to identify gaps and implement the state-run hate crime reporting hotline.

The applicant's strategy or design must include a description of project phases (e.g., strategic planning, implementation, and program assessment), tasks, activities, and staff responsibilities, and clear descriptions of interim deliverables and final products. This should include a description of the strategy for developing and implementing a needs assessment to assess technology gaps unless a needs assessment was conducted in 2019 or thereafter.
- 3. For Purpose Area 1 Describe how the applicant will collaborate with subrecipients, victim service providers, survivors, and other stakeholders.
- 4. Include a time-task plan that clearly identifies objectives, major activities, and products. The time-task plan presented in chart form will not be included as part of the 20-page program narrative limitation. The time task-plan should include the following:
  - a. Schedule for completion of activities.
  - b. The submission of quarterly financial and semiannual progress reports. All awardees are required to submit semiannual progress reports and quarterly financial reports.

- 5. For Purpose Area 1 For states that have already conducted a needs assessment or gap analysis (2019 to present), the application should describe that process and the need for the technology initiative.
- 6. For Purpose Area 1 Describe the development and implementation process over the course of the grant period, which can be from 1 to 3 years.
- 7. For Purpose Area 2 Describe the development and implementation process over the course of the grant period, which can be up to 4 years.

- 3. Describe the specific roles and responsibilities of all project partners and key staff.
- 4. Demonstrate the capacity and expertise of the lead applicant and all project partners to implement the project.
- 5. Demonstrate that the applicant and/or its partners have the expertise to implement the project.
- 6. Clearly describe who will implement activities as described in the Project Design and Implementation section.
- 7. Include descriptions and copies of resumes for proposed key staff positions.
