Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office for Victims of Crime](#) (OVC), seeks applications for funding to develop a toolkit for serving transgender victims of crime. This program furthers the DOJ's mission by being in alignment with Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government § 2(b). Additionally, OVC's Communities of Color Working Group is undertaking an outreach effort to historically underrepresented and underserved communities.

This solicitation incorporates the [OJP Grant Application Resource Guide](#) by reference. The OJP Grant Application Resource Guide provides guidance to applicants to prepare and submit to OJP of applications for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

This solicitation expressly modifies the OJP Grant Application Resource Guide by not incorporating the "Disclosure of Process Related to Executive Compensation" provisions in the "Application Attachments" section.

Solicitation Categories

This solicitation does not include Solicitation Categories.

Eligible Applicants:

City or township governments, County governments, Native American tribal governments (Federally recognized), Native American tribal organizations (other than Federally recognized tribal governments), Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, Public housing authorities/Indian housing authorities, Special district governments, State governments, Other

Other

Eligible applicants are those that are operated by a public agency or nonprofit organization, institutions of higher education, or a combination of such agencies or organizations, and must demonstrate expertise in provision of services to transgender victims of crime.

For purposes of this solicitation, "state" means any state of the United States, the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands.

To advance Executive Order 13929 Safe Policing for Safe Communities, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent

credentialing body or have started the certification process to be eligible for FY 2022 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's use-of-force policies adhere to all applicable federal, state, and local laws and (2) the agency's use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

OVC will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the [OJP Grant Application Resource Guide](#).

OVC may elect to fund applications submitted under this FY 2022 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and on the availability of appropriations.

To register in Grants.gov, the applicant will need to ensure that its System for Award Management (SAM) registration is current.

Step 2: The applicant must then submit the **full application**, including attachments, in JustGrants at JustGrants.usdoj.gov. To be considered timely, the full application must be submitted in JustGrants by the JustGrants application deadline. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats and builds trust between law enforcement and the community.

In June 2021, the White House Domestic Policy Council and Gender Policy Council announced the establishment of the Interagency Working Group on Safety, Inclusion, and Opportunity for Transgender Americans. This is in response to the fact that still today, many transgender Americans, especially transgender women and girls of color, face epidemic levels of violence, discrimination, and stigma. The proposed project will seek to begin to address that issue by funding one entity to create a toolkit with updated information on how to respond to transgender victims of crime, especially for transgender women and girls of color. According to a new study by the University of California Los Angeles Williams Institute, "transgender people are four times more likely than cisgender people to experience violent victimization, including rape, sexual assault, and aggravated or simple assault." This project seeks to develop a toolkit for the field that will inform organizations on how to better serve transgender people, in a culturally responsive and trauma-informed way.

Statutory Authority

VOCA, 34 U.S.C. § 20103(c)(1)(a)

Specific Information

The proposed project will update and expand upon the previously released 2014 OVC guide, [Responding to Transgender Victims of Sexual Assault](#). Since its publication, much has changed and the desire for culturally appropriate services is stronger than ever. The violence aimed at transgender individuals, specifically transgender women and girls of color, may not only include sexual assault, but also harassment, physical assault, domestic violence, human trafficking, and other violent crimes. Often times transgender people are mistakenly treated as the person committing the crime or the aggressor, as opposed to being recognized as the victim. This toolkit will provide information for service providers on how to improve the response to transgender victims through trauma-informed and culturally responsive approaches.

Goals, Objectives, Deliverables, and Timeline

Goals

The goal of this project is to update and expand upon the previously released 2014 OVC guide, [Responding to Transgender Victims of Sexual Assault](#). This will be accomplished through the development of a web-based toolkit that will provide guidance, resources, and referrals for those who provide services to victims of crime who identify as transgender, especially women and girls of color.

Objectives

1. Convene a listening session with service providers and persons of color with lived experience to learn about the concerns that are most pressing for these victims, where there are gaps in service response, and what best practices exist for addressing those gaps and victim needs.
2. Review the current document, [Responding to Transgender Victims of Sexual Assault](#), to determine what information needs to be updated, revised, or deleted. Identify and assess new materials and resources that can be integrated into the toolkit, to include up-to-date definitions and understandings of the issues that transgender victims face, with a special emphasis on transgender women and girls of color. Design and develop these materials. Activities in support of this objective must be carried out with both content and publication design experts, the stakeholder group, and OVC. These web-based materials must be—
 - national in scope, meaning general enough to be used in federal, tribal, and state court jurisdictions across the Nation;
 - translated into multiple languages (e.g., Spanish, Vietnamese) at the appropriate grade level for non-English speakers and those with limited English proficiency (LEP);
 - placed into different web-based formats for individuals with disabilities, and include content appropriate for those with developmental disabilities; and,

- culturally appropriate and relevant to a diverse range of communities. Deliverables include draft and final materials.

While OVC may decide to publish the final toolkit, the applicant should be prepared to do so on its own.

1. Broaden awareness around the victimization of transgender individuals through the development of a dissemination plan that includes using social media, publication of articles, and participation in relevant conferences, workshops, and meetings.
2. Engage an advisory committee made up of a diverse pool of subject matter experts to review the toolkit and ensure the information is relevant, culturally competent, and trauma-informed.

Deliverables

1. A memorandum to OVC that outlines the proposed revisions, updates, and additions for the new toolkit based on what was learned during the document review and listening sessions.
2. A written summary of the feedback received from the subject matter experts.
3. A multimedia, web-based toolkit for victim service providers to be housed and maintained by the grantee.
4. A dissemination plan that includes multiple strategies for ensuring that the toolkit is promoted to the stakeholders, communities, and service providers in most need of this resource.

Such communities include, among others, Black people, Hispanics and Latino/a/e people, Native American and other Indigenous peoples of North America (including Alaska Natives, Eskimos, and Aleuts), Asian Americans, Native Hawaiians, and Pacific Islanders.

In support of Executive Order 13985, OJP will:

- B. Give priority consideration to applicants that can demonstrate that their capabilities and competencies for implementing the proposed project(s) are enhanced because the applicant (or at least one proposed subrecipient that will receive at least 30% of the requested award funding, as demonstrated in the Budget Worksheet and Budget Narrative) identifies as a culturally specific organization.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the project(s).

Culturally specific organizations are defined for purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to, among others, Black people, Hispanics and Latino/a/e people, Native American and other Indigenous peoples of North America (including Alaska Natives, Eskimos, and Aleuts), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas is not a guarantee of an award.

Proposal Abstract

A proposal abstract (no more than 400 words) summarizing the proposed project, including the purpose of the project, primary activities, expected outcomes, the service area, intended beneficiaries and subrecipients (if known), will be completed in the JustGrants web-based form. This abstract should be written in the third person and will be made publicly available on the OJP website if the project is awarded.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 20 pages. Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OVC may consider such noncompliance in peer review and in final award decision. If you are requesting priority consideration, please indicate the priority area (B) you are applying under.

The following sections must be included as part of the proposal narrative:

a. Description of the Issue

This section must describe the need for the project and provide a clear statement of how funding will support the project's value to the victims' field.

b. Project Design and Implementation

This section must describe the project strategy and discuss how the strategy will address the identified problems and support the goals and objectives. The applicant's strategy or design must include a description of project phases, tasks, activities, and staff responsibilities, as well as clear descriptions of the interim deliverables and final products. The applicant must develop a week-by-week time-task plan that identifies major activities and deliverables for the duration of the project period and the designation of staff responsibility. Submission of financial and progress reports must be included in the time-task plan. As a separate attachment, the time-task plan is not subject to the program narrative page limitations. For guidance on OVC's publication process, OVC's Publishing Guidelines for Print and Web Media is available online at <https://ovc.ojp.gov/sites/g/files/xyckuh226/files/publications/infores/pubguidelines/welcome.html>.

c. Capabilities and Competencies

The application must include a clear description of the applicant's management structure and, if the application is for continuation funding, must document the organization's success in implementing previous phases of the project. Applicants must include a description of the current and proposed professional staff members' unique qualifications that will enable them to fulfill their grant responsibilities. The applicant must describe how the program will be managed and include an organizational chart or information describing the roles and responsibilities of key organizational and functional components and personnel. The applicant must also include a list of personnel responsible for managing and implementing the major stages of the project. If additional staff will be hired to complete the project, the applicant should identify the selection criteria. Applicants should also provide detailed information about staff committed to working on the project contingent upon receipt of funding. As a separate attachment, the organizational chart and list of personnel is not subject to the program narrative page limitations.

If the applicant is seeking priority consideration under Priority 1, it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 30% of the project budget) will enhance its ability to implement the proposed project(s).

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

OJP will require each successful applicant to submit regular performance data that show the completed work's results. 2. Project Design and Implementation (40%) - evaluate the adequacy of the proposal, including the goals, objectives, timelines, milestones, and deliverables.
3. Capabilities and Competencies (20%) - evaluate the administrative and technical capacity of the applicant to successfully accomplish the goals and objectives.
4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (20%) - evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
5. Budget (10%) - evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

Other Review Criteria/Factors

Review Process
