#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office for Victims of Crime</u> (OVC) seeks applications for funding to enhance or expand the capacity of national hotlines that are essential for providing crisis intervention services, safety planning, information, referrals, and resources for victims of crime in all 50 states, the District of Columbia, the Commonwealth of Puerto Rico, the U.S. Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands. This program furthers the DOJ's mission by supporting organizations to improve responses, services, and access for victims of crime.

This solicitation incorporates guidance provided in the OJP Grant Application Resource Guide which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

#### **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, OVC seeks to support the enhancement or expansion of national hotlines that are essential for providing crisis intervention services, safety planning, information, referrals, and resources for victims of crime. It also supports participation in the National Hotline Consortium, a group of leading national victim service and crisis intervention hotlines that share technology service delivery and promising practices to provide high-quality support for victims and survivors.

#### **Statutory Authority**

34 U.S.C. 20103(c)(1)(A)

#### **Specific Information**

For many crime survivors, hotlines are a critical resource for immediate and confidential support, especially in rural and remote areas where access to services is limited. Calling, texting, or using other means to access a hotline may be the first step for survivors who need emotional support, safety planning assistance, and referrals to other resources.

National hotlines require an effective and efficient infrastructure to successfully integrate and upgrade technology systems for maintaining and enhancing ongoing operations. Funding to build or improve national hotline infrastructure and capacity will increase access to critical services, allow more continuous and stable hotline support without interruption, sustain uninterrupted access to services and resources, and ensure that helpline services are available in multiple languages and through multiple platforms — whether by phone, live chat, text messaging, or email.

Crisis hotline services should be provided by highly trained staff and volunteers that empower victims and survivors while assessing their needs and identifying appropriate referrals. Those answering hotline calls must be able to (1) identify appropriate reporting agencies and provide information to callers to assist them in reporting or connect callers directly (as a warm handoff) with appropriate providers; (2) provide information, resources, and referrals to other applicable services, such as shelter, housing, counseling, culturally specific and linguistically appropriate programs, legal services; and (3) provide contact information to national or local resources, to address the specific needs of the caller.

For Programs Serving Children and Youth

When providing hotline services for child, youth, or teen victims of crime, services must be tailored to ensure that they are developmentally appropriate, culturally responsive, linguistically appropriate, victim-centered, and trauma-informed. Programs are expected to engage in practices that remove barriers to receiving services and that support survivor autonomy. For youth-serving programs with justifiable mandatory requirements, a <a href="mailto:shared decision-making model">shared decision-making model</a> should be used to provide minors with agency in participating in decisions related to their care. OVC encourages the use of evidence-based and evidence-informed practices when working with all victims of crime.

#### Goals, Objectives, and Deliverables

#### Goals

The goal of this program is to enhance or expand the capacity and infrastructure of national hotline providers to provide crisis intervention support using trauma-informed, culturally and linguistically appropriate, survivor-centered approaches that protect the safety and confidentiality of victims and survivors.

#### **Objectives**

An applicant should address all the objectives listed below in the Goals, Objectives, Deliverables and Timeline web-based form.

- Provide high-quality, trauma-informed services to crime victims and survivors by expanding hotline staffing to improve the ability to provide services and reduce wait times.
- 2. Enhance training for hotline personnel on how to respond to complex crisis situations (e.g., suicide prevention, homicide, human trafficking, child abuse, mass violence) and provide support to minimize their risk and the effects of <u>vicarious</u> trauma and burnout.
- 3. Engage in public awareness campaigns and outreach efforts to increase visibility and awareness of national hotline services, to include trainings or webinars targeted at service providers and community and criminal justice stakeholders.
- 4. Improve access of services and resources by developing culturally and linguistically appropriate materials and resources (and partnering with organizations whose purpose is to create such materials), or improving website accessibility.
- 5. Increase focus on quality assurance and quality improvement by implementing a data-driven improvement process whether in-house or through a contracted provider that enhances service provision, technology processes, reporting, and data analysis capacity.
- 6. Collaborate with the National Hotline Consortium to share technology service

- delivery and promising practices, improve operations, and support accessible, quality victim services and crisis response.
- 7. Work with the National Hotline Consortium to identify the specific needs of victims of cyber- or technology-facilitated crime (gender-based and other harassment and abuse, elder fraud, etc.) and what services are most effective to support resilience and healing.

#### **Deliverables**

The deliverables of this program are:

- Development or enhancement of a training curriculum for hotline personnel to enhance knowledge and service delivery (Year 1).
- Development or enhancement of an automated system for tracking calls and analyzing trends to enhance reporting and data analysis capacity (Years 1–2).
- Development of a quality assurance and improvement plan (Years 1–2).
- Development of a public outreach/marketing plan to increase visibility and awareness of hotline services (Years 1–2).
- Development and delivery of a series of listening sessions in coordination with OVC, the National Hotline Consortium, or other OVC-funded national hotline awardees — to better understand victim service needs that are most urgent for survivors of cyber- or technology-facilitated crimes (e.g., nonconsensual distribution of intimate images, targeted online harassment and abuse, cyberstalking, elder fraud, racially-motivated doxing, and other online violence) that results in a public-facing report with results and recommendations for how the national hotlines might better respond to these needs (throughout the performance period).
- Development of a public-facing <u>annual</u> report that highlights data collected (e.g., services provided, challenges, trends, gaps in services, and National Hotline Consortium efforts).
- Signed Memorandum of Understanding with the National Hotline Consortium (Year 1).

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40**% of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific* organization.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization

This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract. If priority consideration is being requested, please indicate the priority area(s) 1A and/or 1B selected.

#### **Proposal Narrative**

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 25 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, OVC may consider such noncompliance in peer review and in final award decision. Tables, charts, and graphs included in the Proposal Narrative can be created in a legible font smaller than 12-point and will count toward the page limit.

The Proposal Narrative must include the following sections:

- a. Description of the Issue
  - Describe why this project and proposed activities are necessary or address a need or gap in services. Include data as supporting information.
  - Describe how the project will support and provide value to the victims' field. An

applicant should use data to provide evidence that the need for the effort exists and demonstrate the scope and size of the need. The applicant should also make a convincing case that the project addresses a gap in existing resources and does not duplicate an existing program.

#### b. Project Design and Implementation

- Describe the strategy to address the needs identified in the Description of the Issue.
  - Address all the objectives listed in the Goals, Objectives, Deliverables section of the solicitation.
  - List the activities and describe how they relate to the objectives stated in the solicitation. Activities are the specific actions to be undertaken to fulfill the program's objectives and reach the program's goals.
  - Provide a detailed description of the methods to be used to carry out each activity.
  - Provide a timeline indicating when the activities or program milestones are expected to be completed.
- Identify any potential challenges to the project's success and describe how the applicant will address those challenges.
- Describe how the safety and confidentiality of victims will be protected.
- Describe any sustainability measures the applicant will take to continue its efforts beyond the funding period.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

#### c. Capabilities and Competencies

- Describe the capabilities and competencies required to accomplish the goals and objectives of the project.
- Include a list of personnel responsible for managing and implementing the
