1. Please explain any significant change in the number of applications received during the reporting period.

The number of applications received did not change significantly during the reporting period.

2. The average length of time to process an application for claim eligibility for compensation

Count days from time of receipt of application to decision. 40

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. Once the application is complete and submitted to the program the program coordinator at the county level investigates and substantiates the facts of the claim. This includes collecting any bills and obtaining a police report. Once completed the program coordinator will forward the claim to the board for consideration. Once a victim is deemed an eligible claimant by the Board, future expenses can be submitted and processed. Program rules require that a board hear a claim within 60 days of when that claim was received by the program. The board will then determine the eligibility of the claim and approve or deny any expenditures. If the claim is approved payments can be made either to the claimant or directly to service providers. If the claim is denied the claimant or victim is sent a letter via certified mail making them aware of their right to appeal that decision to the board within 30 days of having received the letter.

Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.

During FY 2018, Arizona victim service providers continued to implement new and expanded projects utilizing the increase of VOCA assistance grant funds now available. This resulted in increased awareness and availability of victim services across the state, leading to increased awareness of the victim compensation program. As additional VOCA assistance funding continues to flow to victim assistance programs, demand for victim compensation may increase as well. Yet, there are no additional state or federal resources available to the Arizona victim compensation program to meet the anticipated additional demand.

5. Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.

Victim compensation program advocates at the county level work closely with federal and tribal law enforcement to coordinate access to available benefits for Federal crime victims.

6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

ACJC continues work to develop a victim compensation data warehouse. Utilizing a Vision 21 Technology award for initial development, the data warehouse has greatly improved the quality and availability of program data statewide.

Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

VOCA administrative funds are critical for Arizona's ongoing efforts to improve victim services. The VOCA administrative funds allowed the State of Arizona to pay a portion of the salary and employee related expenses for compensation program staff at ACJC. Because Arizona's program is decentralized, ACJC staff provide county level compliance reviews, training, and technical assistance to ensure county programs are adhering to federal guidelines and Arizona administrative Code related to the compensation program. Technical assistance training and program compliance reviews were conducted at all 15 county programs during FFY18. Additionally, the administrative funds allowed staff to attend the national training conference; providing a forum to meet with OVC staff, increase our knowledge of victim issues, and network with other states on victim compensation issues.

8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

During the reporting period ACJC completed a rulemaking process for the victim compensation program. The majority of changes were related to program administration, but compensation benefits were changed in the following areas: - Include all work loss subsections, except for loss of support, under the maximum amount per calendar week of 40 hours at the current minimum wage - Increase transportation cost maximum from \$1,500 to \$2,000 per victim or derivative victim Program eligibility was changed in the following ways: - Clarify that a victim is not eligible if, at the time of the criminally injurious conduct, the victim was serving a sentence in prison, home arrest, or work furlough; Add incarcerated awaiting sentencing or disposition - Clarify that a claimant is not eligible if, at the time of application submission, he or she is delinquent in paying a state or federal fine, monetary penalty, or restitution - Add automatic ineligibility if program discovers claimant is wanted in Arizona on an active warrant - Clarify that failure to cooperate may include a substantial mental health risk - Exclude as an eligible medical expense any drug, substance, or chemical found under Schedule I of the Federal Controlled Substances Act

The mission statement of the Arizona Criminal Justice Commission is to sustain and enhance the coordination, cohesiveness, productivity and effectiveness of the Criminal Justice System in Arizona. As the state administering agency for the victim compensation program in Arizona the ACJC is able to leverage all available contacts and resources to streamline and coordinate administration of the victim compensation program across all levels of government. These efforts greatly reduce the barriers faced by victims applying for compensation benefits.

Victim compensation program staff at the county level continue to partner with the Arizona Attorney General's Office to provide information during the AG's victims rights awareness trainings. These trainings are conducted across the state and reach a broad audience of victims, providers, and other social service agencies.
