Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. Upon receipt of application, the Program requests information from law enforcement and prosecuting attorneys. When that information is received the case is referred to the case manager for eligibility review and decision. If found eligible, bills are requested from providers and payments are made in the order the claims are received.

4. **Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.**

Although there has not been a significant change in the number of applications received, there is an increase in the number of bills paid. The increase is primarily the result of policy and billing procedure changes in regard to child sexual assault forensic interviews. Idaho Medicaid issued a policy change in 2015 and is no longer providing coverage under the benefits available through Medicaid for the cost of these interviews. Also, two of the largest child advocacy centers in Idaho have adjusted their billing procedures to now bill separately for forensic interviews. This shift has increased claims expenditures and workload for already overburdened staff. The increased workload creates delays in providing timely services to victims who have applied for assistance and who are waiting for their claims to be paid.
5. **Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.**

As part of our annual outreach, staff meets with representatives that provide direct services to victims of federal crimes. We have met with Victim Witness Personnel with the FBI and U.S. Attorney's Office. We routinely communicate with tribal prosecutors, law enforcement and victim advocates to exchange information and documentation to support applications submitted by victims of federal crimes.
6. **Please describe any notable activities during the reporting period that improved the process of victim compensation services.**

We completed Phase 1 of a database system rewrite, which consisted of moving from a server based system to a web based platform. We are continuing with Phase 2 focusing on several enhancements including improving claim processing and increasing access to application and claim status information for victims and providers.

8. **Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.**

Idaho House Bill 429 was passed by the 2018 Legislature and amended the Crime Victims Compensation Act to prohibit the billing of private insurance for adult sexual assault forensic examinations. This has resulted in an increase in adult sexual assault forensic examination reimbursement requests and expenses paid for those examinations by the compensation program.
9. **Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.**

As part of our annual outreach, Program staff travel to meet with representatives that provide direct service to victims of crime in their local communities. We have met with prosecutors, victim advocate groups, treatment providers, court personnel, local law enforcement and victim service personnel at the FBI. We routinely communicate with these individuals on an as needed basis to exchange data and documentation to support applications submitted by victims. Representatives from the Program serve on various local and statewide committees, task forces and work groups that work to enhance the overall systemic response to serving victims of crime.

10. **Please explain any public outreach efforts to improve awareness of your program.**

The Program travels around the state on an annual basis to meet with local law enforcement, prosecutors, victim advocate groups, treatment providers, forensic interviewers, probation and parole officers and social service organizations to ensure that the Program is meeting the needs of victims in Idaho. The goals of each outreach meeting are to: 1) Provide education and information about benefits and services available to victims through the Program; 2) Facilitate the exchange of data and information between our offices to increase efficiency; 3) Develop strong relationships with local officials to ensure that we continue to meet each other's needs and to coordinate services to victims; 4) Connect with other allied professionals in that community to interact or provide services to victims, increasing opportunities to spread the word about the Program and to help victims. Over the past few months we have focused on meeting with SANE nurses and facilities and victim advocates regarding the legislative change effective July 1, 2018 for the billing of sexual assault forensic examinations. The Program measures the following activities in determining effectiveness and efficiency in reducing the financial impact of crime victims. For FFY18: A. Average time to enter an application (date application received to date entered into database)-11 days B. Average time for law enforcement and prosecutors to submit reports (date requested to date all documentation received)-16 days C. Average time to make eligibility decision on application (date application received to date eligibility decision made)-91 days D. Average time to make payment on an application (eligibility date to date of first payment)-31 days E. Utilization of compensation benefits (awarded claims that actually utilized benefits)-56% There are other performance measurements that are tracked and can be furnished upon request.

12. **Please provide any additional comments that are helpful to improving the Victim Compensation state and/or federal program.**

Eliminate the deduction for restitution collections from the State Certification Form for victim compensation programs. This would have a positive impact on the Program's financial bottom line, allowing full value for the efforts taken to collect from offenders.
