NARRATIVE QUESTIONS

1. Please explain any significant change in the number of applications received during the reporting period.

No significant changes for regular applications. The number for Sexual Assault Forensic Examinations increased by 5.26% in FFY17 (FFY17 = 6791 to FFY18 = 7148).

2. The average length of time to process an application for claim eligibility for compensation

Count days from time of receipt of application to decision. 97

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. When an application is received, the first check for eligibility is a check in our claims management system to make sure this claim wasn't filed previously for the victim for the same incident. If there is a claim pending, the new application becomes a part of the pending claim as additional information. If the claim has received a decision, this application becomes a Supplemental Application if the same victim and same incident. The next check for eligibility is done by our field investigation staff who checks all Victims and Claimants for Felony Convictions, Felony arrests, and Felonies pending. If the Victim has a Felony Conviction within 10 years of the incident or with in the pendency of the claim, the claim is denied unless it is a Homicide with minor children. If there is a Felony pending, updates are checked during the pendency of the claim process (120 days) to see if there is a conviction, a reduction, or the charges are dropped. If there are felony arrests during the 10 year period, the claim can be denied for Felonious Conduct but that decision is made by the Assistant Attorney General. The investigation for the claim is done at the same time by both the field investigators and economic loss investigators. The field investigators requests police reports and prosecutor documentation to make sure the crime is eligible for compensation per the Crime Victim Act. They also are checking to make sure the Applicant is a true victim and did not contribute to their injuries which could be a full denial or a reduction of an award. Coroner's reports are requested for all Homicide claims and if the Victim tested positive for a Felony Drug, only minor children are eligible for awards. They also check for Restitution from the offender for any of the expenses claimed, which could make the expenses ineligible if the restitution is paid. Once their investigation is complete, the Field Investigators prepare a Field Report with all of their findings from law enforcement and the prosecutor's office. The economic loss investigators get documentation of all the expenses submitted by the applicant and make sure all available collateral sources are used before the applicant is eligible for an award for those expenses. They also make sure the expenses are eliqible for compensation per the Crime Victim Act. Once their investigation is complete, they prepare exhibits for all expenses submitted and recommend awards for all eligible expenses. Once the field investigation and the economic loss investigation is complete, the Assistant Attorney General reviews all the documentation and makes the determination of the eligibility of all expenses requested. Once complete, they issue a Finding of Fact and Decision. If the Applicant is determined to be ineligible or the expenses are determined to be ineligible, the Applicant can file a Request for Reconsideration to the Attorney General. This is an internal appeal that the applicant is eligible to request. If the investigation for reconsideration determines the Applicant or the expenses are still ineligible, then the Applicant can file an Appeal with the Ohio Court of Claims and a hearing is held before a Single Magistrate. If the Single Magistrate agrees with the Attorney General, the Applicant can file a final appeal with the Judge. The Judge is the final say on all eligibility.

4. Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.

5. Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.

Ohio Crime Victim Services has established a working relationship with the victim advocate's office for the U.S. Attorney and have collaborated on several cases, including the murder of 2 Westerville police officers.

6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

The Attorney General's Office has continued increasing awareness of the crime victim compensation program and improving access to victim services during this reporting period. Examples of our efforts include: the Crime Victim Services outreach program, the Linking Systems of Care grant and continued development of a new compensation claims management system. The Crime Victim Services Section staff has continued implementing the compensation outreach program during this federal fiscal year. Staff members have visited multiple organizations including non-profits, grant recipients, law enforcement agencies, and other community partners to provide information about how victims can apply for the compensation program and what expenses may be covered. These efforts help to ensure a smooth process for victims as agencies who are provided with accurate and complete information about the program can better assist victims with applying for compensation. Some of the office's community partners requested ongoing, updated training, and we have also reached out to new partner agencies during this time. The office received continuation funding for an OVC-funded grant entitled "Linking Systems of Care for Children and Youth". The focus of this project is to coordinate training and services for Ohio victim service providers. The office has started victim service collaboration with statewide agencies and coalitions, and these efforts will continue throughout the year. In addition to direct outreach efforts, the Attorney General's Office continues to pursue technological advancements to claim processing. As previously reported the online compensation application is fully functional and has received positive feedback from users. The office is actively working to purchase a new claims management system. This new claims

management system will provide greater access for victims to information regarding their applications. Additionally, the system will promote greater internal efficiency with respect to claims processing, allowing claims investigators to focus additional time on helping victims. The office is aggressively moving forward with implementation of the new software, which is estimated to begin in calendar year 2019.

Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

No administrative funds are used from the grants. All grant funds are used to pay claims.

8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

Marsy's Law, the Ohio Crime Victims Bill of Rights, was enacted by voters in November 2017. The law affords victims certain rights, including the right to be present and heard at all court proceedings, receive notice of release of the offender, and offer input on pleas deals. Additionally, victims have the right to refuse discover, the right to a prompt conclusion of their case, and the right to restitution. The measure repealed Section 10a Rights of Crime Victims of the Ohio Constitution and replaced the section with Marsy's Law. The Attorney General's Office developed a Marsy's Law reference card to assist law enforcement and victim service provider with notifying victim about their rights. In October 2017, the Sexual Assault Forensic Exam (SAFE) program began reimbursing hospitals that issue HIV prophylaxis to patients at risk of exposure. In collaboration with the Ohio Department of Health, a risk exposure protocol was developed for hospitals as part of the state's Medical Forensic Exam process. Ohio Administrative Code 109:7-1-02 Sexual assault examination payment amount (B) was enacted with effective date of 7/24/2017. A hospital, children's advocacy center, or other emergency medical facility shall accept payment of the actual amount billed; not to exceed twenty-five hundred dollars, as payment in full for any cost incurred in administration of HIV post-exposure prophylaxis protocol in rule 109:7-1-01 of the Administrative Code. Total payments made during the reporting period is \$196,194.20

Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.

Each year our office holds trainings and conferences to help victim advocates and law enforcement agencies. Finding the Words (FNDW) training was held on 4-9 thru 4-13-18. This is an intensive five-day forensic interviewing course using practice guidelines from the American Professional Society on the Abuse of Children (APSAC) and Office of Juvenile Justice and Delinquency Prevention (OJJDP) outlined in the bulletin. Two Days In May Conference on Victim Assistance (TDIM) was held 5-14 thru 5-15-18. The 2018 conference marked the 27th year holding the event. The theme to the conference was "Protecting Ohio's Children." The conference was attended by over 1,200 victim advocates and included featured speakers and 35 workshops to address issues and advocacy training. The Attorney General's Office partnered with 16 different groups to help protect Ohio families for this event. A Sexual Assault Symposium was held on the second day at the TDIM conference. The symposium was an opportunity for law enforcement officials and prosecutors to learn about sexual assault investigation-related topics, including looking into cold-case sexual assaults, working with sexual assault victims, and working with Combined DNA Index System (CODIS) program. The CODIS program blends forensic science and computer technology into a tool for linking violent crimes. It enables federal, state and local forensic laboratories to exchange and compare DNA profiles electronically, thereby linking serial violent crimes to each other and to known offenders. The Basic Advocacy Skills in Crime Victim Services (BASICS) training was held 8-27 thru 8-31-18 with 49 participants attending. BASICS is a week-long, intensive course offering 33 ½ hours of baseline education for new professionals in the field of victim services. The course is designed to focus on the expansion of knowledge and training for victim service providers. Participants develop skills in the area of child abuse, domestic violence, legal advocacy, crisis intervention and death notification.

10. Please explain any public outreach efforts to improve awareness of your program.

Staff members from all units of the Attorney General's Office Crime Victim Services Section volunteer time away from their daily job responsibilities to work on the section's statewide outreach initiative. The goal of these outreach efforts is to improve access to the crime victim compensation program and other victim services, and to increase the number of compensation claims filed. During this reporting period, Attorney General staff visited various organizations, including VOCA/SVAA grant recipients, social service groups, law enforcement and other community partners to provide information about how the crime victim compensation program can assist victims, and to explain how these organizations can help victims to apply for compensation. These interactions ensure partner agencies are knowledgeable about how to complete and file compensation applications, so they can provide accurate information about the compensation program to the victims they serve. Outreach program efforts include ongoing or updated training that occurs periodically, such as the Crime Victims' Rights and Responsibilities Course at the Ohio Peace Officer Training Academy, and the five day BASICS academy training for victim advocates. Additionally, the office has focused efforts on attempting to expand the audience for these trainings and reach out to newly-contacted groups who could benefit from information about the compensation program. Some examples of compensation outreach efforts during this reporting period include: • Presentation for law enforcement, prosecutors, and victim advocated in Lorain County. This was a new location that had not recently been visited by compensation staff. • Presentation for attorneys, paralegals, and advocates at Legal Aid of Western Ohio, another group of professionals not previously visited. Professional training at the Ohio Domestic Violence Network's Domestic Violence Advocacy Fundamentals regional courses. This is a training held periodically by ODVN with audience consisting of new victim advocates or who request refresher training. • Presentation for "peer mentor" Youth Corrections Officers at the Ohio Department of Youth Services. These outreach efforts combined with the implementation of the online compensation application have contributed to an increased number of claims filed across the state. By the end of calendar year 2017, many counties met or exceeded the number of claims filed in the previous calendar year. Several of the more populous counties where outreach events were held show consistent or increased numbers of new claims filed, including Lucas County (Toledo), and Hamilton County (Cincinnati). We

Legislative changes to having money available for relocation fees for domestic violence victims and all victims who need to relocate immediately to be safe from offenders. Victims can request publication from our office on line. Publications includes: Crime Victim Right's Booklet, Crime Can be Costly palm cards (also in Spanish), VINE brochures, Applications and Resource Guides. We also provide translation of 20 different languages thru Language Line Services.
