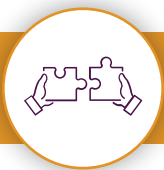

The tool, a 30-topic questionnaire, was tested by U.S. service providers during a two-year study funded by the National Institute of Justice. It is available at no cost; no permission required.
