A paper application is received by this Agency and entered into our electronic case management system by an Administrative Assistant. The file is then passed on to the Executive Director for initial review and assignment. Once the claim is assigned to an Investigator, the Investigator reviews the available crime report for eligibility requirements and is responsible for obtaining any other information required to make said determination. The Executive Director and Investigators meet on a weekly basis for a Decision Meeting. At the Decision Meeting, the Investigators present all of their cases and present the proposed decision letter to the Executive Director for signature.

In an attempt to reach more victims of crime, this Program has increased its outreach and training efforts. Most notably, this Program is housed in the Delaware Department of Justice. During the reporting period, efforts have been made to internally train both Prosecutors and Victim Advocates to ensure that appropriate referrals are being made to the Program.

VOCA Administrative Funds were used to send employees to the National Association of VOCA Assistance Administrators National Training Conference as well as for other training opportunities. Over half of our staff has 2 years of experience or less, so training opportunities are vital in improving victim compensation services.

This Program's focus during the reporting period has been establishing internal policies and procedures surrounding the payment of claims. These internal changes have allowed for a more streamlined and efficient process.

Further, during the reporting period, efforts were made to internally train both Prosecutors and Victim Advocates to ensure that appropriate referrals are being made to the Program.

The Victims' Compensation Assistance Program is well known throughout the state; however, this program considers outreach to be an important program component.
