When that information is received the case is referred to a case manager for eligibility review and decision. If found eligible, bills are requested from providers and payments are made in the order the claims are received.

The number of claims received for forensic interviews and examinations continues to have an impact on workload for staff. This increased workload can create delays in providing timely services to victim who have applied for assistance and who are waiting for their claims to be paid.

As part of our annual outreach, staff meets with representatives that provide direct services to victims of federal crimes. We routinely communicate with tribal prosecutors, law enforcement and victim advocates to exchange information and documentation to support applications submitted by victims of federal crimes.

6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

We continue to work on enhancing our database system. We are currently working on a systems modernization program for our agency, assessing needs and evaluating options.

As part of our annual outreach, Program staff travel to meet with representatives that provide direct service to victims of crime in their local communities. We have met with prosecutors, victim advocate groups, treatment providers, court personnel and local law enforcement. We routinely communicate with these individuals on an as needed basis to exchange data and documentation to support applications submitted by victims.

10. Please explain any public outreach efforts to improve awareness of your program.

Representatives from the Program serve on various local and statewide committees, task forces and work groups that work to enhance the overall systemic response to serving victims of crime. This year Program staff have personally met with 80+ criminal justice agencies, advocacy groups and treatment providers to ensure that the Program is meeting the needs of victims in Idaho.
