Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. Once an application is received, an acknowledgement letter is sent to the claimant and a letter requesting police information is sent to the law enforcement agency. If no bills are received from the claimant within 30 days the claim is denied for lack of cooperation with the division. If bills related to the crime are received they are added to the claim. Once police information is received, if the information submitted indicates any illegal activity of mis-conduct on behalf of the victim the claim is denied. If the information is favorable to the claimant and the officer indicates the case was sent to the prosecutor's office, a request is sent to the prosecutor's office. Once that information is received and is favorable to the claimant, a bill verification is performed for any bills to be paid. along with tax ID numbers being verified for each provider. Once this is done, the claim is submitted for approval. If the claim is denied for any reason, the claimant has the right to appeal the division's decision. If they submit a formal request a hearing is scheduled in from of the administrative law judge. The ALJ's decision is handed down 10 days after the hearing.
