NARRATIVE QUESTIONS

1. **Please explain any significant change in the number of applications received during the reporting period.**

The Office of Claims and Appeals (OCA) has held steady with the increased number of claims filed for the period 07/01/2022 through 09/30/2022 as compared to the same period in 2021. 89 claims were received during the same period in both years. The OCA's training program has seen a reduction in the number of trainees from 92 for the period of April to October 2021 to 51 for the same period of 2022. However, the breadth of trainee has expanded in 2022. In 2021, trainees typically consisted of law enforcement/prosecutor-based advocates and officials. However, in 2022, OCA staff trained trainees from a wider variety of disciplines: law enforcement/prosecutor-based advocates, systems-based advocates, legal aid societies, Children's Advocacy Centers, Court Appointed Special Advocates, and allied nonprofits.

2. **The average length of time to process an application for claim eligibility for compensation**

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. Upon receipt of a filed claim, the Executive Staff Advisor/Clerk enters the claim into the CVCB's electronic database, generates initiating correspondence to the Claimant, the prosecution if applicable, and to the Claimant's private attorney if applicable. The Clerk then forwards the case file to the investigator. The investigator conducts their investigation into the filed claim, which includes but is not limited to: conversations with law enforcement officials about the circumstances of the crime (whom was involved, relationships amongst involved parties, whether any conduct was exhibited by the survivor to indicate culpability in their injuries or death, etc.); verification on legal obligation of expenses submitted for compensation, outstanding balances, and payments made by survivors and insurance carriers; and obtaining missing information so as to allow the Board to have sufficient information upon which to base an award or denial. The investigator then drafts their investigative report, has the report viewed by the staff attorney, and then submits the full file to the Executive Staff Advisor/Clerk upon assent by the staff attorney. After receiving the complete file from the investigator, the Executive Staff Advisor/Clerk drafts a draft recommended order and after drafting assigns each case to one of the CVCB's three Board Members. The Board Member reviews the investigator's report and the draft recommended order prepared by the Executive Staff Advisor/Clerk and indicates their recommendation to the Executive Staff Advisor/Clerk. If the draft order is satisfactory, no edits are made. If the Board Member's recommendation differs from the draft recommended order, the Executive Staff Advisor/Clerk will edit the draft order to accurately reflect the Board Member's desire before serving on the Claimant, the prosecution if applicable, and the Claimant's private attorney if applicable. The Claimant is afforded fifteen days to register disagreement with the recommended order in the form of an interagency appeal or exceptions. Once the recommended order has been served, the Executive Staff Advisor/Clerk places each claim on the Board's next available agenda for adjudication. Two weeks prior to the Board's meeting, the Executive Staff Advisor/Clerk submits the complete docket to the full Board, which includes each Board Member's vote indication, each served Recommended Order, and each investigative report. The full CVCB then meets at its regularly scheduled or specially called meeting to adjudicate all claims on its docket. Once adjudicated, the Executive Staff Advisor/Clerk drafts the CVCB's final orders for all claims on the docket and serves them on all appropriate parties. In the event that a claim is awarded, the Executive Staff Advisor/Clerk submits payment requests to the PPC's Office of Administrative Services (OAS) for processing through the Commonwealth's accounting system and mails checks upon receipt from OAS after processing.

4. **Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.**

The Kentucky CVCB has continued to meet the needs of survivors whom have filed compensation claims during the reporting period. One potential issue that may surface in the future, or may be in the beginning stages of doing so currently, is that the Kentucky CVCB may not be able to as effectively meet the needs of survivors given the increased claim filings and low staff levels.

5. **Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.**

No additional steps were taken during the reporting period to serve victims of federal crime because strong relationships already exist between the Kentucky CVCB and both districts of the U.S. Attorney's Office along with the Federal Bureau of Investigation's Louisville branch. When a potential claim arises, representatives from both districts of the U.S. Attorney's Office and the FBI's Louisville branch will reach out to the Clerk and discuss the circumstances of the crime to determine if the CVCB may be able to provide compensation to the victim.

6. **Please describe any notable activities during the reporting period that improved the process of victim compensation services.**

The Executive Director, Staff Attorney, the Executive Staff Advisor, and the Sexual Assault Examination Program Coordinator with the Kentucky CVCB are currently taking part in a working group with state Senators and other allied professionals to discuss potential changes to CVC statutory and regulatory provisions in order to improve victim compensation services.

7. **Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.**

Not Applicable. OCA does not use VOCA Administrative funds. All received VOCA funds are directed to victim compensation payments.

8. **Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.**

In September 2022, the Kentucky CVCB implemented a bereavement policy for Claimants who lost loved ones due to homicide. The policy allows for Claimants to receive up to four weeks of lost earnings constituting bereavement with just the submission of the Employment Verification Form, provided that the time missed from work can be verified with the employer as being due to the homicide. The Physician s Statement nor the Mental Health Counselor s Report are not required for a bereavement award to be made. The Kentucky CVCB is currently discussing whether to implement a policy to allow awards for emotional support animals.

9. **Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.**

The Executive Staff Advisor still sits on all of these committees. In addition, the Executive Director, Staff Attorney, and the Executive Staff Advisor are currently working with one of Kentucky s VOCA grant administrators to possibly use VOCA assistance funds to hire a victim advocate to assist claims investigators with helping survivors obtain missing documentation for their claims, assisting with training and outreach efforts, and other duties. One of the most time consuming activities that claims investigators undertake is working with survivors to obtain all needed documentation. The victim advocate s actions should go a long way in alleviating this burden for the claims investigators and improve access to CVC services.

10. **Please explain any public outreach efforts to improve awareness of your program.**

The Kentucky CVCB continues to hold monthly trainings on crime victims compensation with victim advocates, prosecutors, law enforcement officials, and other allied professionals whom work in the victims services field. One of OCA s staff attorneys and the Executive Staff Advisor made a public appearance on behalf of the CVCB at Frankfort s Pride festival held on October 8, 2022 and plan on making more in-person appearances as circumstances allow.

The Kentucky CVCB does not regularly report program outcome measures to the governor, legislature, or other state entities. Pursuant to KRS 49.300(8), by January 1 of each year, CVCB is required to submit an annual report to the Office of the State Budget Director and the General Assembly s Interim Joint Committee on Appropriations and Revenue setting forth the activities of the CVCB for the preceding state fiscal year, including a complete operating and financial statement. OCA has not yet completed and submitted the FY22 annual report. However, the legislature recently requested various pieces of data regarding the Kentucky CVC program and the Sexual Assault Examination Program for state fiscal years 2019-2022. Specifically, the legislature requested information regarding the source of CVCB s appropriations; CVCB s expenditures for the requested time period; the source of and reimbursement rates for federal funds; amount paid out in CVC claims per year; amount paid out in Sexual Assault Examination claims per year; the source of OCA s restricted fund revenue; and whether the legislature s understanding of other specifics of the CVC and SAE programs were correct. We have enclosed with this survey a spreadsheet, CVCB 2019.2022 (Final) , that lays out the information provided by OCA in response to the legislature s request. In addition, we provided the following claim data for state FY22 in response to the request.
