In addition, victims interacting with prosecutors and victim service providers are provided with information on victim compensation and how to apply. Victims can complete either an online or paper application. Online applications are automatically routed to the county operational unit assigned, which is based on where the crime took place. Victims completing a paper application are directed to send the application to the county operational unit where the crime took place. Once the application is complete and submitted to the program, the program coordinator at the county level investigates and substantiates the facts of the claim. This includes collecting any bills and obtaining a police report. In addition to gathering and substantiating the facts of the claim, the coordinator will negotiate with service providers to reduce the cost of services for the claimants. Once all necessary information is obtained and verified, a packet is completed to be forwarded by the program coordinator to the county crime victim compensation board for consideration. Once a victim is deemed an eligible claimant by the Board, future expenses can be submitted and processed. Program rules require that a board hear a claim within 60 days of when that claim was received by the program. The board will then determine the eligibility of the claim and approve or deny any expenditures. If the claim is approved, payments can be made either to the claimant or directly to service providers. If the claim is denied the claimant or victim is sent a letter via certified mail making them aware of their right to appeal that decision to the board within 30 days of having received the letter.

Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.

During this past year, the overall number of applicants filing a victim compensation claim increased to a level similar to pre-covid years. In April of 2023, ACJC received a supplement of American Rescue Plan Act (ARPA) funds for the Victim Compensation Program through the Arizona Governor's office. These funds have been instrumental in maintaining the program's ability to serve all victims applying for victim compensation with no delay or reduction in services. These funds will allow the program to meet the increased needs of victims through the end of next year.

5. Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.

County coordinators continue to work with federal and tribal law enforcement to coordinate access to benefits for federal crime victims on tribal lands. In addition, ACJC staff in conjunction with Arizona State University and a state legislative subcommittee are coordinating to improve access to victim compensation for all Native American victims of crime with an emphasis on outreach to families of missing and murdered indigenous women. ACJC has participated in a number of tabling events and information-sharing sessions this past year.

6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

ACJC staff met with FBI victim specialists to provide training and discuss crime victim compensation. ACJC staff then invited the FBI victim specialists assigned in Arizona to attend a meeting with all 15 county coordinators. These collaboration efforts have been very beneficial to our county operational units, especially relating to federal or tribal crimes.

Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

VOCA administrative funds are critical for Arizona's ongoing efforts to improve victim services. The VOCA administrative funds allowed the State of Arizona to pay a portion of the salary and employee-related expenses for compensation program staff at ACJC. These positions are particularly important to Arizona since our program is decentralized. ACJC staff provides county-level compliance reviews, training, and technical assistance to ensure county programs are adhering to federal guidelines and the Arizona Administrative Code related to the compensation program. Technical assistance, training, and program and financial compliance reviews were provided to the counties during this federal fiscal year.

8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

During the reporting period, ACJC began the rulemaking process for the victim compensation program. Feedback was received from the operational units. ACJC will continue the process in the next reporting period.

Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.

As the state administering agency for the victim compensation program in Arizona, the ACJC can leverage all available contacts and resources to streamline and coordinate the administration of the victim compensation program across all levels of government. These efforts significantly reduce the barriers faced by victims applying for compensation benefits. Arizona also has a state agency coordinating team (AZSACT). This team's mission is to collaboratively assess needs, maximize state and federal resources, support intervention and prevention activities, and improve quality services for crime victims and survivors while positively influencing policies and practices. These agencies include the Governor's Office of Youth, Faith and Family (GOYFF), the Office of the Attorney General (AGO), the Department of Health Services (DHS), the Department of Economic Security (DES), the Department of Housing (ADOH), the Department of Public Safety (DPS) and the Arizona Criminal Justice Commission (ACJC). ACJC utilizes membership in the AZSACT to promote the Arizona Victim Compensation program and to collaborate with other agencies to reduce barriers for victims across the state who may apply for compensation benefits.

10. Please explain any public outreach efforts to improve awareness of your program.

County programs regularly provide public outreach through training and local tabling events at local social services fairs and other community activities. An example of this is the Navajo County Attorney's Office of Victim Services which hosted a one-day training symposium for advocates, students, and interested community members during crime victim rights week. ACJC staff provided support by tabling at the event. ACJC staff have also participated in providing training at the twice-yearly Victim Advocate Basic Academy, and the Annual Four Corners Indian Country Conference. ACJC staff have also maintained a virtual victim compensation basic training on our website.
