Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. 1. Applications are received M-F via mail or electronically via a webform. The start date is the date that the application is received by the CVC Program. Incoming applications are accepted and triaged by intake staff with receipt acknowledgment letters and requests for initial documentation sent out to applicants before transfer of the claim to a specialist for an eligibility determination. Law enforcement reports are also requested at this time for review by claims specialists. 2. Once applications are fully entered by intake staff, initial letters are sent out, and LE reports are requested, the claim is transferred to the claims specialist. 3. Once LE reports are reviewed, claims specialists make an eligibility determination. This eligibility determination may change at a later date if there is non-cooperation from the applicant or other disqualifying information comes to light.

4. **Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.**
WI CVC continues to spend a significant amount of time working on a case management system change from Salesforce to Journal Technologies. The Go-Live is scheduled for December of 2023. The testing and pre-implementation of this new software has been extremely time consuming for CVC staff. Additionally, 2 CVC claims specialists were allowed to decrease their FTE status (for work-life balance and to avoid losing them completely), resulting in the need for additional staffing to meet the needs of workload and claims processing. OCVS was unfortunately not approved for our request of a new permanent GPR funded claims specialist in the 2023-2025 biennial state budget.
5. **Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.**
The Wisconsin Crime Victim Compensation Program regularly provides informational trainings to a variety of stakeholder agencies and victim services providers throughout the state, including Federal VW and Crime Response staff and community-based victim service providers that serve tribal communities. Many of the community-based providers receive VOCA or VAWA subgrants and are required to attend trainings about various victim service programs and resources. CVC staff is a component of all of these mandatory trainings.
6. **Please describe any notable activities during the reporting period that improved the process of victim compensation services.**
-Significant efforts continue with the configuration of a new CVC Claims Processing database which has had some delays but will go live in December 2023. This will include a portal for applicants to check claim status and submit documentation. CVC continues to actively engage in outreach and training with community partners, victim service organizations and providers as needed and/or requested. -CVC is actively working on a "Plain Language Letters" project intended to improve the victim/applicant understanding and readability of CVC correspondence.
7. **Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.**
CVC VOCA Administrative funds were used for fringe, operational costs, and one temporary part time additional CVC staff position of the CVC team within the WI DOJ Office of Crime Victim Services to help address our application intake backlog. The additional position was closed during this grant period. CVC VOCA Admin funds also supported the technological needs of CVC staff via the Salesforce Case management database and providing technological support through our Bureau of Computing Services. CVC admin grant funds were also used to attend trainings for staff related to CVC program work, administration and victim services.
8. **Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.**
2023 Assembly bill 59 was proposed: "Under the bill, if a building is intentionally damaged by means of fire or explosives, the owner of the building may receive compensation from the victim compensation program. The amount of the award is equal to the difference between the amount paid by insurance and the cost of necessary repairs or the fair market value of the building, whichever is less. The bill maintains the \$40,000 cap on an award from the victim compensation program for damage to a building." CVC program director has made efforts to educate lawmakers on the impact of this bill, as paying for property damage is not an allowable expense with VOCA and is not the result of a personal injury, which the bill also proposes to add to the definition of personal injury.
9. **Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.**
Crime Victim Compensation staff regularly communicates directly with District Attorney's offices and Victim Witness staff in order to assist victims to coordinate the documentation of their financial losses due to a crime. By sharing information, with the victim's informed consent, CVC staff alleviates some of the stress and burden of documenting losses that would otherwise fall on victims directly. CVC staff also coordinates with VOCA State Administrators to engage in training advocates on the fundamentals of CVC, how to apply, and where to go with questions on a routine basis throughout the year.
10. **Please explain any public outreach efforts to improve awareness of your program.**
Crime Victim Compensation staff conducts multiple trainings for advocates statewide on the fundamentals of CVC, how to apply, and where to go with questions on a routine basis throughout the year. These trainings are well attended and attendee feedback is requested to continually improve outreach efforts. Staff also trains on the fundamentals of CVC at regular Victim Witness conferences and trainings. CVC has also made a concerted effort to participate in community events and activities in which an information table is staffed by OCVS team members to provide information to the community on our programs and services.

12. **Please provide any additional comments that are helpful to improving the Victim Compensation state and/or federal program.**
Currently, collected restitution monies from offenders can only be used for additional claims payouts to victims. CVC is adequately funded by State GPR allocation and the VOCA compensation formula grant. CVC is very backlogged on claims payouts due to inadequate staffing and will need to request an extension of the FY 21 grant (and likely subsequent grants) in order to get the money out the door. The primary remedy that will improve our ability to spend out claims is additional staffing to process the claims, or we will continue to operate in a backlog on grant spending. We are proposing a law change which would allow the use of restitution monies to be spent on the administration of victim services programs.
